

CALL TO ARTISTS: 2024 Members Holiday Art Show & Sale

The Florence Arts Council is pleased to announce the Members Holiday Art Show & Sale! The Members Annual Holiday Show and Art Sale is **open only to all current paid up FAC/Bell Tower Members**. The show has an Open Theme and is open to all media, both 2-D and 3-D art, prints of original work, giclee, textiles, wearables and more. This show enables the public to appreciate and give fine art during the holidays while allowing F.A.C. the opportunity to support our member artists. Items sold during the show may be taken down once paid for and Member Artists have the option of restocking items sold during the run of the show.

Entries Submitted: no later than 4pm November 19, 2024 to the Bell Tower. (open 10am–4pm)

Exhibit Display: November 20 to December 24rd, 2023

Public Reception and Holiday Decorating Party: November 20th 3–6pm (Stay for Open Mic 6-8pm) (Artists, friends, family and the public are invited to come help decorate the Bell Tower during the reception.)

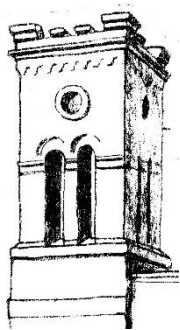
Pick-Up Work: December 23rd 2024 to January 10th 2025

Sales: The Bell Tower will retain 25% Member commission on all sales. All work must be listed for sale.

Entry Fees: No entry fees. Current paid up F.A.C. Members may enter up to 3 pieces. When an item sells, the member artist will have the option to restock.

Entry Rules:

- ◆ “Multiples of small items” will be accepted and considered as “one item” under the following parameters: Multiples of small items may be shown only as part of a larger display (**no larger than 30” x 36”**). The individual small items (such as ornaments, books, bags or card sets) must be marked & inventoried separately so that they may be tracked even though they are part of your larger display and attached to a frame or other display apparatus, ready for showing. Individual Artist Inventory Sheets are at the Bell Tower or able to be downloaded online)
There is limited table and flat space for display items. First Come, First Served. Hanging displays are preferred.
 - ◆ Card Sets, Books or Grab Bags that are multiples must be packaged, marked and in their own display.
 - ◆ Jewelry must be securely attached for display & in a display format that is ready to hang.
 - ◆ Textiles and wearables must be mounted on their own appropriate hanger/ready to display.
- ◆ Each item is limited to a maximum size of 30” x 36”; regardless of if it is one painting or a display of smaller items.
- ◆ All work must be ready for display with items marked and securely attached.
- ◆ All work must be labeled with the artists label on the back containing the title, price, medium, artist’s name and contact info.
- ◆ Wall art must be gallery ready with wire securely attached to the back and be ready to hang.
- ◆ Work must be dry and have a finished appearance with appropriate framing or finished edges. Wires for hanging.
- ◆ Work must be picked up on the designated dates, unless arrangements are made. Work left longer than 90 days becomes the property of the FAC.
- ◆ The Visual Arts Committee reserves the right to deny entries that are deemed to be in poor taste, offensive, or that do not follow entry parameters.
- ◆ **Liability:** Make sure that your display is adequately secure for the items that you are selling. The Bell Tower/FAC suggests the artists carry their own insurance. All reasonable care will be taken, however the Bell Tower/FAC will not be responsible for damage/loss whatever the cause. Your entry constitutes agreement with these terms and conditions.
